**Ms. Lindsey Moritz Awarded the 2007 AWSS Travel Scholarship**

Ms. Lindsey Moritz, a Master's student at the University of Wisconsin-Madison, was awarded the 2007 AWSS Travel Scholarship at the AWSS Annual Meeting November 6th in New Orleans, Louisiana.

Ms. Moritz was chosen from a highly accomplished and impressive pool of young women to receive the \$500 scholarship to support her travel to the ASA-SSSA-CSA Annual Meetings in New Orleans. This was the third

year AWSS has awarded the scholarship to an up-and-coming female soil scientist making their first presentation at a professional meeting.

### Kari Sever on Job Shadowing

Today, I had the unique opportunity to participate in a "Job Shadow" program. Job Shadow is a part of the introductory soils course at Eastern Oklahoma State College in which each student in the class is challenged to follow a soil scientist or conservationist for a day, as part of their course credit requirement. The student then is required to write a 2 page paper covering the tasks performed and their experience. The individual that accompanied me for the day is a sophomore from Eastern Oklahoma State College (a small two-year college in southeast Oklahoma) and is majoring in horticulture. She is graduating with an Associate Degree in horticulture in May and transferring to a 4-year college next fall, but is currently on the soil judging team and loves it.

In selecting the agenda for the day, I had to consider that my

most interesting work on the schedule requires travel, and I only had one day of the student's spring break schedule to work with. Not wanting to waste precious time by driving to far away places, I chose to do local septic evaluations for the Job Shadow program, so we could cover more variety of soils and situations. We completed 3 septic evaluations at 3 locations, including 1 percolation test and 2 soil profiles and the clients included both contractor and individual. It was a great opportunity to show the variation of results when using the perc test vs. the soil profile description. Between the 3 sites, we augered into sandy loam over sandstone, clay, secondary carbonates, and "redbed" shale with relict redoximorphic features.

Perhaps it would be a good idea if more university professors required students to "Job

Shadow" or at least offer it as "extra credit/bonus points" for the introductory soils class. These particular students from EOSC were told to go to their local NRCS office and ask to Job Shadow a government employee, but they also had the option to accompany another qualified person, if they knew of one. My Job Shadow student knew of me because I had designed her parent's septic system over a year ago.

It was a great experience for us both, but I have to admit that I was disappointed when I learned that she planned to study elementary education next fall and her career goals include being a grade school teacher. On the optimistic side, maybe she will take her enjoyment of soils to a new level within the primary education system by incorporating soils in the elementary classroom.


Perhaps it would be a good idea if more university professors required students to "Job Shadow" or at least offer it as "extra credit/bonus points" for the introductory soils class.

**Past Ask Mother Earth...** I am working on my master's degree in soil morphology and would like to get a job as a soil scientist with the federal government (NRCS or Forest Service). I keep watching the job postings at USAJOBS, but there are very few openings for entry-level soil scientists. What can I do to increase my chances of getting my dream job?

Please pass this message to the person doing her masters in morphology and looking for a Federal job - The Forest Service also uses the SCEP program. I would advise her to contact the Regional Soil Scientist in the areas of the country she is interested in working. I can help with contacts in the west. Also, she should be aware that with a master's degree, she qualifies for GS-9 level jobs - a step above entry level. If she is interested in working for the Forest Service, I would recommend at least one course in environmental analysis and enough coursework to qualify as a hydrologist - many Forests are advertising jobs that involve both hydrology and soils - and sometimes these are only advertised in the hydrology series. ### Post-Doctoral Fellowship, University of British Columbia

A postdoctoral fellow has become available in the Forest and Mycorrhiza Ecology Research Group, University of British Columbia Okanagan, Kelowna, Canada.

It requires an individual with a background in soil organic matter chemistry and an interest in soil microbiology. S/he will be responsible for characterizing forest floor from pine and spruce sites subjected to optimal nutrition fertilization. Experience in proximate analysis, in quantifying microbial biomass and N mineralization rates and in interpreting elemental and isotopic ( $^{13}C$ ,  $^{15}N$ ) composition and NMR of SOM is essential. The objective is to determine whether soil microbial communities have adjusted physiologically to changes in SOM chemistry resulting from fertilization.

The research, which is funded by an NSERC Strategic Grant, will involve interaction with scientists and grad students from two other universities and government agencies. Funding is available at \$35,000CAN/year (plus benefits) for two yrs. Starting date is negotiable, but summer 2008 is ideal.

The successful candidate will join an established research group (see <http://web.ubc.ca/okanagan/biophgeo/research/fame.html>) housed in 6000 sq ft of new lab space. UBC Okanagan is a new rapidly-growing campus located in the resort community of Kelowna. The Okanagan Valley has a moderate climate and is a center for wine and fruit production and is also a destination for skiing and water sports.


